RE-TENDER NOTICE

Ernakulam Regional Co-operative Milk Producers' Union Limited invites quotations from reputed manufacturers/distributors/dealers of for the supply of 1000 Ltrs.+_50 Vertical Freezer for ERCMPU Ltd

1. Price Basis:

The sealed and super scribed quotation shall be received in our Office on or before 13.01.2026, 4.00 PM and will be opened on the same day at 4.30 PM.. The quoted rate shall be inclusive of all applicable branding, taxes, duties, packing and forwarding, freight and insurance and three year warranty at free of cost.

2. EMD

The bidder shall remit the EMD amount (non interest bearing) indicated in this notice along with the tender in form of Demand draft, drawn in favour of the Managing Director, ERCMPU Ltd, payable at Ernakulam. The EMD can also be remitted by cash at our office from 10.00 a.m. to 3.00 p.m. during working days.

3. Validity:

The offer should remain valid for acceptance for a period of 90 days from the date of opening of bids. On mutual acceptance Managing Director ,ERCMU can extend the period of contract to 03 (three) more months .

4. Agreement

Successful bidder should execute an agreement within 7 days from the date of purchase order in non-judicial stamp paper (Kerala) worth ₹ 200/- for satisfactory completion of work. shall obtain membership with ERCMPU by paying a nominal membership fee of Rs. 90.00.

5. Security Deposit

- The EMD of successful Bidders will be taken as the Security Deposit and will be released only after the successful completion of delivery & bid validity.
- If the performance of the contractor is not satisfactory or if the contractor tends to withdraw from the contract before maturity period, the ERCMPU Ltd shall have the right to terminate the contract and make an alternative arrangement and the additional loss thereby incurred by the Dairy for the completion of the contract period shall be recovered from the contractor. In such cases the Security deposit remitted by the contractor will be forfeited in favour of ERCMPU Ltd.

- c. In case of negligence or misconduct of supplier or his Staffs or due to the problems in operation of his transportation vehicle any loss/ damage occurred to the assets (fixed or movable) of the Dairy will be recovered from supplier's eligible bills/Security deposit.
- d. The bidder shall meet all the eligibility criteria specified above. In case, If it is found out that the bid Information/documents uploaded to this effect are false/incorrect/forged, after awarding contract, the tender inviting authority has the right to summarily reject their bid and the security deposit remitted by the party will be forfeited and will not be refunded.

6. Artwork

The art work shall be supplied by us. Contractor has to contact the concerned section for the artwork after the receipt of Purchase Order.

7. Delivery :

The Vertical Freezer shall be delivered at Products Dairy, Edappally within 20 days from the date of Purchase Order.

8. Payment:

- a. 5% of the total value of the contract amount rounded to the nearest rupee shall be remitted or a bank guarantee of equal amount shall be submitted to Manager Products Dairy by the successful bidder as **security deposit** for releasing the entire payment.
- b. **On receipt of security deposit**, 100 % of the total contract price will be paid from the concerned unit within 15 days on receipt of the items in the above destination in good condition, on submission of original invoice and recommendation from concerned department.
- c. Security deposit shall be released only after the satisfactory completion of the warranty period. No interest shall be paid for the period during which the Security Deposit lies in deposit.
- d. The security deposit will be forfeited in favour of ERCPMU Ltd., in case of any violation of the terms and conditions or abandoning of the contract by the contractor without due notice.

9. Warranty:

The supplier shall guarantee the satisfactory performance of the vertical freezer for a minimum period of 12 months from the date of delivery. Any defect due to use of substandard material or workmanship shall have to be replaced by the supplier at his own cost within 48 hours of reporting.

10. Liquidated Damage Clause:

If the supplier fails to deliver any or all of the goods or perform the contract within the time period specified in the contract, ERCPMU Ltd shall without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to

- a. 0.5 % of the unexecuted contract value for each week of delay. The total amount so deducted shall not exceed 5% of the contract value. Failing to supply in time, we may consider the termination of the contract.
- b. Any incidental taxes and levies on account of delay in performance of the contract by the supplier shall be at his account.

However genuine reasons if any will be given due consideration, on production of documentary evidence before operating the liquidated damages clause.

11. Testing/ Test Certificate:

The successful Bidder shall produce the Test Certificates for the material for inside basket & lid (which is coming in contact with food-stuff), Puf etc used in the construction of the Freezers.

12. Service Network:

The supplier should have good service network with qualified personnel so as to cater the Ernakulam, Kottayam, Thrissur and Idukki districts of Kerala. **The address and phone no. of the authorized service centres should be submitted along with the tender. Non submission of the above details may lead to rejection of the tender.**

13. Arbitration & Jurisdiction:

- In case of disputes arising out of this tender, an arbitrator as mutually acceptable to the supplier and union will be appointed by the Managing Director, ERCPMU Ltd. The arbitrator's decision shall be final, conclusive and binding on both the parties.
- In case if either supplier to the tender is aggrieved by the award of the arbitrator so appointed as per clause above or otherwise, the jurisdiction for the same will be Ernakulam District and as per the provisions of Kerala Co-operative Societies Act and Rules 1969.

14. Deviation Statement:

Non-compliance with even a minor technical requirement, terms and conditions should be specifically stated by the bidders in the technical deviation statement to be uploaded along with the bid.

15. Managing Director, ERCPMU reserves the right to cancel or reject or accept or withdraw or extend the tender in full or part, as the case may be, without assigning any reason thereof. Any offer containing incorrect and incomplete information shall be liable for rejection. The Ernakulam Regional Cooperative Milk Producers Union Ltd. will not be responsible for any kind of online delay.

The quantities declared for tender are only estimated and liable for variation. During the contract period, the supply shall be on staggered basis to various units as per the schedule given by ERCPMU. ERCPMU reserves the right to delete the item/s declared for tender in full or partly at the time of finalization of contract or during the contract period. The quantity that would be purchased from the selected tenders depends on the quality & performance of material supplied. No claims in this regard shall be entertained.
